

Canada: Unauthorized health products may pose serious health risks

Health Canada is advising Canadians about unauthorized health products that may pose serious health risks. The table below is updated when Health Canada finds unauthorized health products that are promoted for sexual enhancement, weight loss, as a workout aid, or as “poppers,” and that are labelled to contain or have been tested and found to contain Sildenafil, Vardenafil, Yohimbine and Zopiclone.

The unauthorized health products are:
